No.NBE-2/EX-10/2022-23/1102: The following rules/instructions pertaining to HSLC Examination 2023 are hereby published for information of all concerned:

MARKSHEET /MARKSHEET cum PASS CERTIFICATE :

- (a) Marksheet /Marsheet cum Pass Certificate shall be collected by the **concerned Centre Superintendents**. It shall be issued from 29th & 30th May 2023.
- (b) Collection of marksheet/marsheet cum Pass certificate by candidates :

- Candidates must produce their original admit cards at the time of collection of marksheet/marsheet cum Pass certificate.**
- (c) Marksheet /Marsheet cum Pass Certificate shall not be issued to candidates from this Office.
- (d) Original marksheet cum Pass certificates are issued to successful candidates. As such, provisional certificate of qualification need not be issued by the institutions. Further, institutions who admit students should not insist on provisional certificate of qualification.

CORRECTION:

Any mistakes in the Marksheet/Marsheet cum Pass certificate must be reported within 30 days after the publication of the Result Gazette for rectification. Such cases should be routed through the institution/centre. (refer Management of Examinations)

Corrections, if any, in the marks/grades shall be intimated to the concerned school/centre through an authorised Board's Official.

Correction in the admit card shall not be entertained as the stipulated time is over.

POST PUBLICATION RESCRUTINY:

- (a) Rescrutiny of answer-scripts in any number of subjects is permitted. The application should be routed through the school/centre.
- (b) Candidates applying for rescrutiny can apply online at www.nbsenl.edu.in within 15(fifteen) days after the publication of the result, i.e., on or before 8th June 2023. The prescribed fee of ₹500/- per subject shall be paid online in the portal.
- (c) Rescrutiny results shall be declared within 40 (forty) days after the declaration of this result.

POST PUBLICATION RESULT:

- (a) Rescrutiny result shall be sent to all registered institutions.
- (b) The rescrutiny result is not notified individually.
- (c) Corrigendum and addendum of this result gazette shall be published along with the rescrutiny results.
- (d) Rescrutiny result will be made available on Board's website (nbsenl.edu.in)

PHOTOCOPY OF ANSWERSCRIPTS:

- (a) Photocopy of answerscripts shall be provided to candidates on fulfillment of the terms and conditions.
- (b) This provision shall be extended only to candidates who applied for rescrutiny and in the subject(s) they applied.
- (c) Candidates who did not apply for rescrutiny shall not be eligible to apply for photocopy of the answerscripts.
- (d) The application for photocopy of the answerscripts should be submitted in the prescribed Form no. 4 to the Board's office on payment of fee of ₹1000 per subject. The application shall be accompanied by HSLC Marksheet-cum-Certificate.
- (e) The last date for submission of application form is within 15 days after declaration of rescrutiny result.

INFORMATION FOR HSLC REPEATERS

A repeater candidate shall appear the HSLC Examination as per the existing prescribed syllabi and course of the examination concerned.

Repeaters shall submit the Application forms and Exam fee for HSLC Examination 2024 online during 1st to 12th August 2023.

HSLC IMPROVEMENT EXAMINATION 2023

The HSLC Improvement Examination shall be conducted in June 2023. A successful candidate at the main HSLC Examination 2023 desirous of improving his/her performance is eligible to sit for this Improvement Examination in three or less subjects.

A candidate who qualified at the main HSLC Examination 2023 but secured Needs Improvement Grade in one subject is also eligible to sit for the HSLC Improvement Examination 2023.

Candidates have to apply online through the NBSE portal. The rate of fees is ₹600 per subject. After the online application is submitted, the student will get a message to give their examination fee to the respective school. The school/centre after verifying the forms shall make the payment online.

The student also shall surrender their original Admit Card and Marksheet for onward submission to the Board. It should be submitted to the school/centre from where their forms were verified.

HSLC COMPARTMENTAL EXAMINATION 2023

The HSLC Compartmental Examination 2023 will be conducted in June 2023. A candidate with Needs Improvement grades in 3(three) or less subjects is eligible to sit for the HSLC Compartmental Examination. Candidates have to apply online through the NBSE portal. The rate of fees is ₹600 per subject. After the online application is submitted, the student will get a message to give their examination fee to the respective school. The school/centre after verifying the forms shall make the payment online.

The student also shall surrender their original Admit Card and Marksheet for onward submission to the Board. It should be submitted to the school/centre from where their forms were verified.

ISSUE OF MIGRATION CERTIFICATE

Students can apply for Migration Certificate online at nbsedup@gmail.com. The prescribed fee of ₹500/- (which is inclusive of postal charges) shall be paid to SBI Account No. 10530523670, IFS Code SBIN0000214. The scanned copies of the payment receipt, admit card, marksheet-cum-pass certificate in respect of HSLC candidates and admit card & marksheet in respect of HSSLC candidates should be emailed. Proper postal address of the student should be indicated clearly in the application. The Board shall send scanned copy of the Migration Certificate through e-mail and the hard copy will be sent by post.
